 - 2. Align with SBOE Policy (Academic Affairs will contact T.J. Bliss)
 - 3. Discussion as to whether this is an 'internal' HR issue or not

- 4. External review letter writers need to Associate or Full Professor rank. Will make this explicit in the policy
- ii. Question regarding whether the discussions of the P and T Committees themselves be confidential or not
 - 1. This was unanimously agreed on as 'Yes'

 - 1. Appointments vs. elected seats
 - a. Recommendations for veto power

 - d. Conflict of interest statement
 - e. Add wording 'students may' and leave up to the departments to decide whether or not students can vote on these committees along with the SBOE language
