Sept 9, 2024 Statement to Faculty Senate

Please excuse me for taking time during this open forum. I know this time is customarily reserved for visitors. I will be brief. I will also provide these remarks in a written statement for the minutes so that anyone can review my remarks.

My hope is that this year the Senate can complete several important tasks. To this end, I would like to highlight three items of unfinished business I feel should be of interest to new and returning members of the Faculty Senate and one additional item of importance to my constituents.

First, as many of you are aware, the last president at ISU pushed forward a faculty workload policy with great urgency during the final months before his departure. I would remind Senators that we have yet to see any data on faculty workload from across campus. The policy clearly states that the policy's effective date is December 14, 2023. At this time, I know that the College of Science and Engineering is not following the new workload policy, ISUPP 4090. This confusion over the faculty workload policy is particularly troubling as we prepare for an accreditation visit by the NWCCU.

Second, the Faculty Senate debated a statement on the Evaluation of Administrators on May 1, 2023. The statement was tabled at the request of the Administration to allow time for their feedback on the statement. Many of you are aware ISU has conducted votes of no confidence in the past. I can tell you from personal experience this is not desirable outcome. I think it would be much better management practice to identify potential problems before they reach a critical level. Boise State has a policy on evaluation of administrators. The proposed statement is based on Boise State's policy. I feel we should make a motion to remove this statement from the table and invite the administration to share their thoughts with us.

Third, given the continued rising costs of education, several faculty members took it upon themselves to analyze the historical changes to the university budget. These faculty members submitted a report indicating that, while faculty costs have remained relatively flat, administrative costs have risen substantially. On February 26, 2024 the Faculty Senate received and reviewed this report. The administration created a work group to respond to this report. The minutes of the Faculty Senate indicate that Steve Byers was appointed by the Senate to the Administrative Cost Work Group on March 11, 2024. It is my understanding that this Work Group has not met. Therefore, I will be making a motion that the Faculty Senate forward this report to President Wagner for his consideration.

Finally, all the engineering programs went through an accreditation visit last year. The accreditors wrote in their report that they were concerned that there were less than two full-time administrative assistants supporting six programs. The University responded that two full-time administrative assistants would be employed to support the engineering programs. One administrative assistant subsequently retired in August of this year. The Administrative Council declined to fill this open position. So, we now have only one administrative assistant. I worry that this will jeopardize the accreditation of our engineering programs. In the time that I have remaining, I would like to ask Interim Provost Bradford to help us understand why the Administrative Council declined to fill this open position. I yield the remainder of my time to Provost Bradford.
